# 01. Introduction

## 1.1 Overview of the Crypto Market in 2024

# 02. The Problem We See

The cryptocurrency market is growing rapidly, but it faces a number of key challenges that limit its efficiency and attractiveness. One of the most serious is the lack of liquidity, which affects all aspects of trading, from the speed of order execution to price stability.

## 2.1 Liquidity Challenges

Lack of liquidity remains one of the most pressing issues for traders and crypto platforms.

### How it manifests itself:

- Market fragmentation: Liquidity is spread across multiple exchanges and platforms, creating disparities in asset prices and leading to delays in order execution.
- Price slippage: With low liquidity, asset prices can change significantly during the transaction process, increasing the cost of transactions.
- High costs: Lack of liquidity forces platforms to increase commissions to compensate for risk.

### How this affects traders:

- The cost of transactions increases.
- It is difficult to conduct transactions with large volumes of assets.
- It is difficult to work with less liquid cryptocurrencies.

## 2.2 The Need for a Reliable Liquidity Source

For efficient operation, the platform requires constant access to liquidity, which allows it to provide:

- Stable order execution.
- Honest rates without sharp price jumps.
- Minimal commissions for transactions.

However, attracting liquidity requires significant resources. That is why we have created an investment program that solves the problem of liquidity shortage and at the same time provides users with an opportunity to earn money.

## 03. Our Solution

Moonacy offers a comprehensive solution to the liquidity problem by involving private investors. Our investment program allows users to invest in the platform to support liquidity pools and receive a stable income from the platform.

### 3.1 How the Investment Program Solves the Liquidity Problem

The investment program is directly related to solving the problem of lack of liquidity. Funds invested by private investors serve as the basis for the creation of liquid pools, which provide

- **Faster execution of trades:** Increased liquidity allows traders to execute transactions immediately, minimizing slippage.
- **Lower transaction costs:** Deeper pools of liquidity reduce bid-ask spreads.
- **Improved trading conditions:** High liquidity makes exchanges favorable for both retail and institutional users.

In addition, a portion of the platform's commission and margin revenue is used to reward investors. This creates a mutually beneficial model: investors receive a stable income and the platform strengthens its position due to the high level of liquidity.

### 3.2 Investment Plans and Benefits

In order to attract investors with different levels of capital and financial objectives, we have developed several investment plans:



#### Momentum

For investments between \$100 and \$9,999, offering a **0.95% daily return** over a period of 150 days.



#### Middle Pool

For investments between \$10,000 and \$29,999, offering a **1.35% daily return** over a period of 120 days.



#### Multi Bridge

For investments between \$30,000 and \$49,999, offering a **1.85% daily return** over a period of 90 days.



#### Moonacy Prime

For investments between \$50,000 and \$200,000, offering a **2.5% daily return** over a period of 60 days.

Investors can also choose to reinvest profits to grow their capital through compound interest.

# 04. Technical Architecture

Moonacy's platform architecture is designed for high performance, security and scalability. We use advanced technologies to ensure the reliability of all systems, including transaction processing and investor interest calculations.

## 4.1 Automated Market Maker (AMM)

Moonacy uses an Automated Market Maker (AMM) system to provide users with high liquidity and instant transaction processing. This technology allows cryptocurrency exchange without the need to find a counterparty. Instead of traditional order books, AMM uses liquidity pools that automatically adjust asset prices.

### How does AMM operates?

- 1. Liquidity pools:** Each liquidity pool consists of two or more cryptocurrencies deposited by liquidity providers (users who contribute assets for trading). For example, the BTC/ETH pool holds specific amounts of bitcoin and ether. These pools are used to perform exchange transactions between users.
- 2. Automatic pricing:** Unlike traditional exchanges, where the price is determined by supply and demand in the order book, AMM automatically calculates the price of assets. When a user buys or sells assets from the pool, the balance of assets in the pool changes and the system automatically updates the price. The larger the transaction volume, the more it affects the price.
- 3. Exchange without counterparties:** The user does not have to wait for the other party to accept his order. Instead, he interacts directly with a liquidity pool that provides the right volume of cryptocurrency.

### Example of how AMM works on Moonacy

Imagine a user wants to exchange bitcoin for ether. Instead of searching for another trader who is willing to reverse the trade, the user interacts with the BTC/ETH liquidity pool. The system automatically calculates how much ether he will receive in exchange for the specified amount of bitcoin and finalizes the transaction instantly.

### How does Moonacy minimize the problems of AMM?

- 1. Liquidity pools:** We maintain a large volume of assets in pools to minimize price fluctuations, even for large transactions. This is especially important for users making large transactions, as they can be assured of predictable prices.
- 2. Liquidity management:** The platform analyzes trading volume and demand for certain cryptocurrencies in real time. Based on this data, liquidity is redistributed between different pools to ensure that users can always transact at a fair price.
- 3. Slippage minimization:** Slippage occurs when a large transaction has a large impact on the price of an asset. We use optimized algorithms that adjust volumes and prices to reduce such changes. This makes trades on Moonacy more favorable for users.
- 4. Transparency and predictability:** All processes within AMM are transparent and predictable. Users can see in advance how their transactions will affect the price, allowing them to make informed decisions.

## 4.2 Smart Contract Integration

All investment and trading operations on the Moonacy platform are executed through smart contracts. They automate the interest calculation process, ensure transaction execution and protect user funds. Smart contracts ensure the security and transparency of all transactions.

Here is an example of a liquidity management smart contract:

## 4.3 Matching Algorithm

In order to ensure fast trade execution, Moonacy uses an algorithm that aggregates buyers' and sellers' orders with minimal lag time:

1. Determining the best available offer/demand.
2. Accounting for order volume and liquidity.
3. Automatically executing the trade.

Mathematically, this can be represented as follows:

**$F(p, q) = \operatorname{argmin} |P_{\text{sell}} - P_{\text{buy}}|$** , where:

- **$F(p, q)$**  is the optimal pair to execute the trade.
- **$P_{\text{sell}}$**  is the selling price.
- **$P_{\text{buy}}$**  is the buy price.



# 05. Investor Returns and Investment Plans

Moonacy offers a variety of investment plans tailored to suit different levels of investor participation. These plans are designed to reward users for contributing liquidity to the platform, ensuring a sustainable ecosystem while offering attractive returns.

## 5.1 Investment Plans

We offer five levels of investment plans, each of which guarantees a daily income depending on the amount invested:

	Investment range	Daily yield	Investment period	Description
<b>Momentum</b>	\$100-\$9,999	0.95%	150 days	Fast cryptocurrency exchanges for small amount in popular directions.
<b>Middle Pool</b>	\$10,000-\$29,999	1.35%	120 days	The main pool of liquidity for popular pairs with stablecoins.
<b>Multi Bridge</b>	\$30,000-\$49,999	1.85%	90 days	Large high-yield exchanges between different networks.
<b>Moonacy Prime</b>	\$50,000-\$200,000	2.5%	60 days	Use assets in all types of exchanges to get maximum results.

## 5.2 Example of yield calculation

### Example for Momentum plan

Investor deposits \$1,000 under the terms of the Momentum plan:

- Daily income:  $0.95\% \cdot 1,000 = \$9.50$
- 150-day income:  $\$9.50 \cdot 150 = \$1,425$ .
- The total amount for the entire term will be:  $1,000 + 1,425 = \$2,425$

### Example for Moonacy Prime plan

Investor deposits \$50,000 by choosing a Moonacy Prime plan:

- Daily Income:  $2.5\% \cdot 50,000 = \$1,250$
- 60-day income:  $1,250 \cdot 60 = \$75,000$ .
- The total amount for the entire term will be:  $50,000 + 75,000 = \$125,000$

## 5.3 Rewards and Payment Mechanisms

### Profit allocation:

- Investors' income is paid from trading commissions collected by the platform. These commissions provide a reliable source of payouts, ensuring transparency and sustainability.

### Frequency of payouts:

- All payouts are made daily, allowing investors to see the results of their investment immediately.

### Reinvestment:

- Investors can reinvest their profits, increasing their total capital and returns through the effect of compound interest.

## 5.4 Allocation of Investor Funds

Invested funds are allocated in the following ways:

### 1. Liquidity pools (75-85% of funds):

The majority of investor funds are used to increase the liquidity of trading pairs on the platform. It allows:

- Reducing slippage on exchanges.
- Providing competitive prices to users.

### 2. Allocation of funds in pools:

Funds are allocated in proportion to the popularity and volatility of the trading pairs.

Here is an example of the allocation:

- Pairs with high trading volume get more weighting ( $W_i$ )

- Allocation formula

$$P_i = \frac{V_i \cdot W_i}{\sum (V_i \cdot W_i)}$$

$P_i$  - share of funds in a pair  $i$ ,  $V_i$  - trading volume  $W_i$  - volatility ratio

### 3. Reserve Fund (10-15%):

Creating a financial cushion to ensure stability of payments to investors during periods of high volatility.

### 4. Operating costs (5-10%):

Covering the costs of maintaining the platform, including security, infrastructure development and user support.

## 5.5 Liquidity Pool Mechanism

Moonacy uses an Automated Market Maker (AMM) model where liquidity is provided by pools based on a constant product:

$$x \cdot y = k$$

Where:

- $x$  — amount of asset A in the pool
- $y$  — amount of asset B in the pool
- $k$  — the pool's unchanged balance constant

Example:

- liquidity pool contains 100 ETH и 10 BTC ( $k = 1,000$ ).
- If a user sells 1 BTC for ETH:
  - New BTC balance:  $10 + 1 = 11$ .
  - New ETH balance:  $\frac{k}{11} = 90.91 \text{ ETH}$ .
  - Received amount of ETH:  $100 - 90.91 = 9.09 \text{ ETH}$ .

This allows for dynamic price changes based on the current state of the pool, ensuring trading stability.

## 5.6 Taking volatility and risk into account

To minimize volatility risks, funds are reallocated based on historical data:

- Trading pairs with high volatility receive more liquidity to smooth prices.
- Pools with lower demand are regularly updated to avoid overstocking.

### Risk Management Formula:

- Funds are reallocated every 24 hours based on the liquidity ratio

$$R_i = \frac{\Delta V_i}{\Delta T}$$

$R_i$  — change in the trading volume of a pair  $i$ ,  $\Delta V_i$  — volume change,  $\Delta T$  — time interval

This allows for dynamic asset management and improved performance.

## 5.7 Advantages of Moonacy Investment Plans
